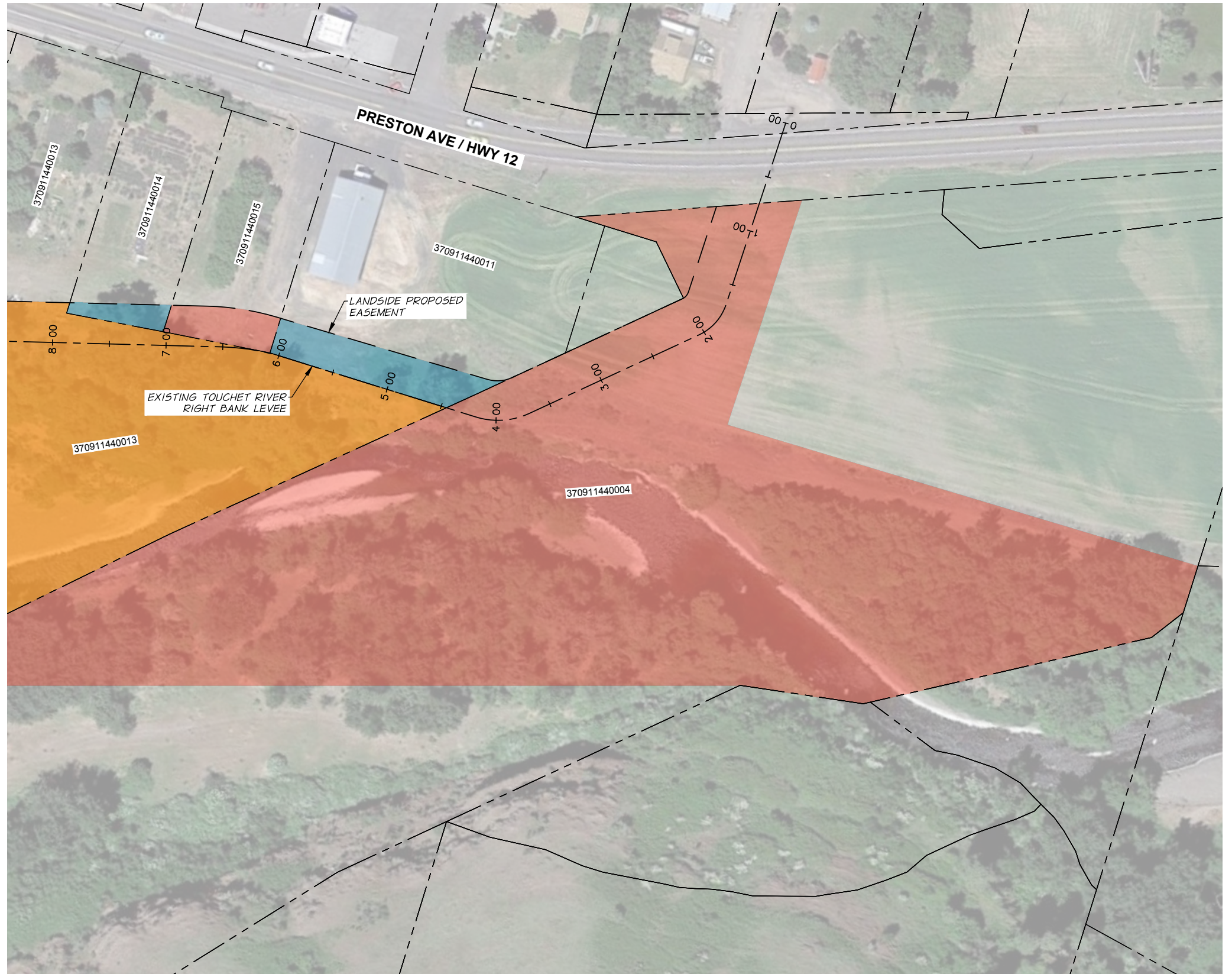

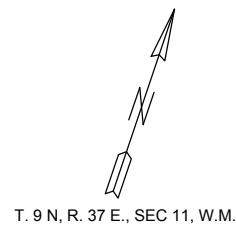

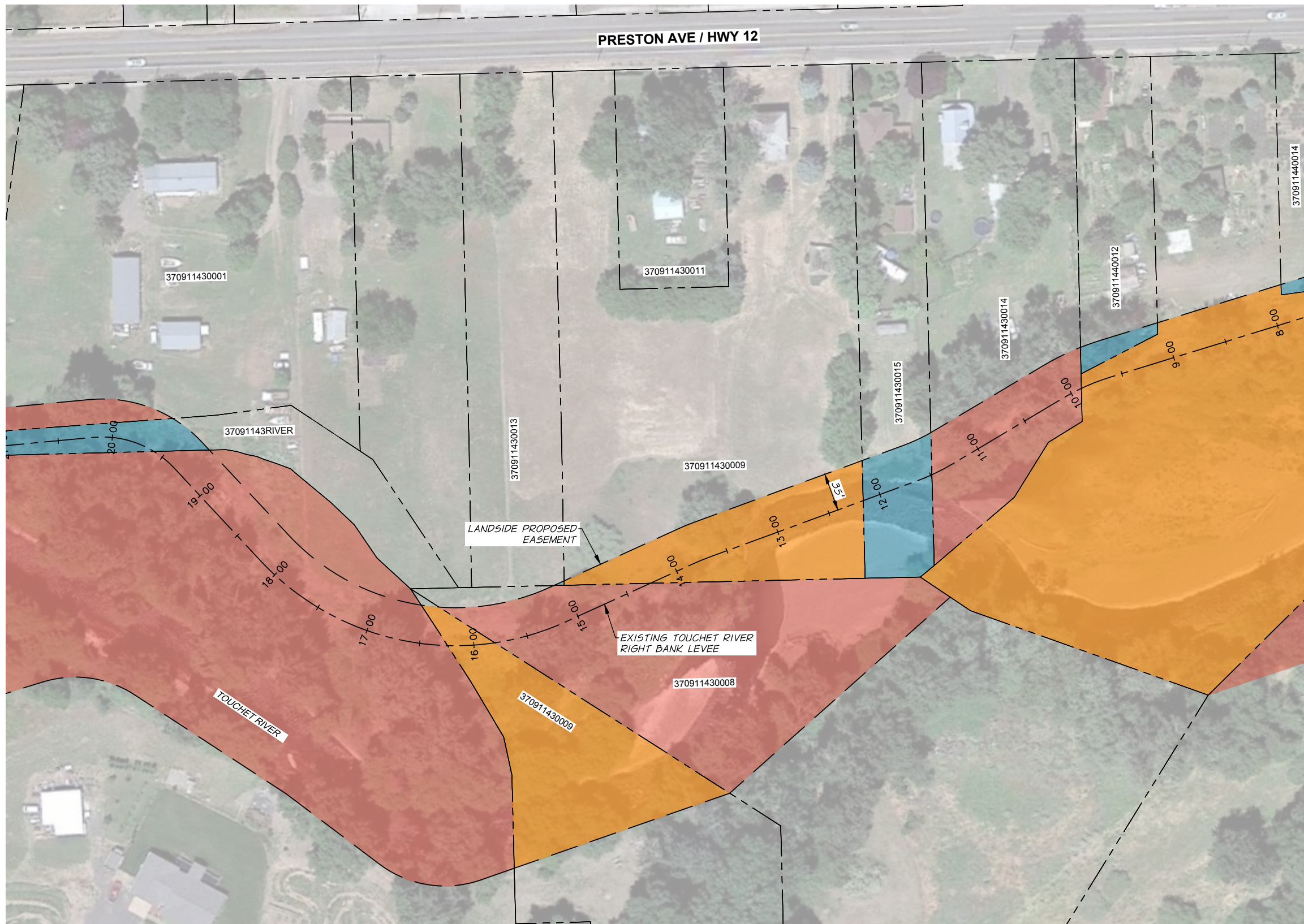


HORIZONTAL SCALE IN FEET

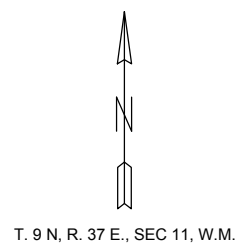

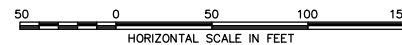
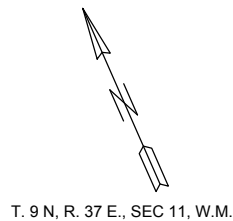
